Separate sealed bids for the Orwell Village WTP Improvements will be received by the Village of Orwell, located at Orwell Village Hall 179 West Main Street, Orwell Ohio 44076 (Ashtabula County), until 12:00 o'clock noon (local time), October 20, 2023 and then in said office publicly opened and read aloud.

The work covered by the CONTRACT DOCUMENTS includes the following:

Make improvements to the existing Water Treatment Plant (WTP) to include relocating the chlorine injection port, replacing and reconfiguring the supply piping to mount the meter horizontally, replace the butterfly valves with throttling valves, replace and raise the existing high service pumps with VFD pumps and associated electronics and electrical wiring.

The Engineer's opinion of probable cost for this project is \$126,500.00 as of January, 2023.

Bid security furnished in Bond Form, shall be issued by a Surety Company or Corporation licensed in the State of Ohio to provide said surety.

Each Proposal must contain the full name of the party or parties submitting the proposal and all persons interested therein. Each bidder must submit evidence of its experiences on projects of similar size and complexity. The Project shall be substantially complete on July 5, 2024 and totally complete on July 19, 2024

All contractors and subcontractors involved with the project will, to the extent practicable use Ohio Products, materials, service, and labor in the implementation of their project. Additionally, contractor compliance with the equal employment opportunity requirements of Ohio Administrative Code Chapter 123, the Governor's Executive Order of 1972, and Governor's Executive Order 84-9 shall be required.
