Special Meeting

Date: May 23, 2023

Council Vice President Hartz called the meeting to order at 4:30 p.m. The Pledge of Allegiance was recited.

Roll Call: Clerk Kimberly McKinley performed roll call and the following council members were present: Mr. Cottrell, Ms. Cozad, and Mr. Hartz. Absent: Mr. Denihan and Mr. Ruks.

New Business:

Mrs. Pentek explained that the Ashtabula County Engineers office was notified by OPWC requesting the Village of Orwell remove all demolition from scope and funding for the water tower project. In addition, update new CFO and engineering estimates and remove loan portion from application. OPWC does not pay for demolition unless a new tower is being built. Updated application needs to be submitted ASAP. Tower removal is an EPA request. Mrs. Pentek, Shawn Aiken and Patrick Blake w/CT Consultants and W/S Superintendent Nevison with Shane Hajjar OPWC district liaison held a discussion via video conference. CT request conference for clarification. The demolition portion of project was an oversight on OPWC behalf.

Ms. McKinley explained that the resolution previously passed by council specified Renew or Replace existing .5 mill levy. Language needs to be changed to Replaced only. Ashtabula County Auditor's office will certify the dollar amount revenue will generate. Council will need to pass prior Resolution 23-05-03R again. Resolution and auditor certificate must be filed with the board of elections to place levy on ballot.
