Streets/Lands & Buildings:

Mrs. Pentek provided a summary of her written report. A community development meeting was held at village hall; Ms. Pentek will provide an update next month. The street department is continuing to address issues with storm sewers and drainage ditches. Easement paperwork has been submitted to the owners of Capp's Pizza building. Breezewood was discussed. Downspouts run all the way through storm pipes impeding flow. Kings could hydro excavate and cut spouting in storm pipe. The village would be responsible for topsoil & reseeding. TSC assisted with the removal of flags. The Police department would like to replace the carpet with tile; Mr. Gregory is working on quote.

Water/ Sewer:

Police Department:

Mrs. Pentek provided a summary of her written report. Weapon requalification has been completed. Officer Ryhal and Officer Brockway completed Advance Criminal Investigation training.

Fire Department:

Mrs. Pentek provided a summary of her written report. Water tank leaking and the truck will only be used in the village with the use of hydrants. A new truck will be added to CIP. The paint on Tanker 335 is failing and is covered under warranty. The engine may be out of use for a few months.
