Mrs. Pentek provided a summary of her written report. The police department is seeking estimates in replacing surveillance equipment inside the building. Two body cameras are out of service. Mr. Ruks would like to see them replaced ASAP.

Fire Department:

Mrs. Pentek provided a summary of her written report. Fire Chief Merlino submitted a grant for turn out gear and extraction tools through BWC. Engine 332 poly water tank is split and leaking. The engine was purchased from E One; Chief Merlino will check for warranty.

Park and Recreation

A meeting was held on August 11, 2023, at Grand Valley Public Library. Discussion included flower displays for next season and planning of Christmas Parade and lighting ceremony. The committee inventoried Christmas items in storage at village hall on September 3, 2023.
