REGULAR Meeting

Date: January 16, 2024

Council President Ruks called the meeting to order at 4:42 p.m. The Pledge of Allegiance was recited.

Roll Call: Clerk Kimberly McKinley performed roll call and the following council members were present: Mr. Cottrell, Ms. Cozad, Mr. Denihan, and Mr. Ruks.

Agenda:

Mr. Denihan made a motion, seconded by Ms. Cozad to add to the agenda the appointment to council and the resignation and appointment as vice president of council. The motion passed with all in favor.

Ms. Cozad made a motion, seconded by Mr. Cottrell, to open the floor for nomination to the vacant council seat. The motion passed with all in favor.

The board approved the 2024 operating budget. Other items discussed at meeting included dispatch contract, year-end filing, 2022-2023 Audit, CMS reporting, inventory, training, and accident information update. Next meeting is scheduled for February 13, 2024, at 7:00 p.m.

Mrs. Pentek provided a summary of her written report. Chief Merlino reported that the department submitted a grant to be reimbursed for training. A 240 class will be held in the fall of 2024. Windsor purchased a battery for the repeater system. Chief Merlino held a presentation on the Knox boxes with GV Chamber members.

Planning & Zoning Commission: Next meeting is January 31, 2024, at 1:00 p.m.

Solicitor's report: None

Finance Report: Ms. McKinley provided a summary of her written report.

Mr. Hartz made a motion, seconded by Ms. Cozad, to approve the finance report. The motion passed with all in favor.

Zoning: Mr. Bellas provided a summary of his written report. Updating website and codification of zoning code was discussed. Mr. Bellas provided a draft of a public nuisance ordinance, increase level of misdemeanor and fine to help deter habitual offenders. Section 6:03 of the village charter does not specifically address code violations within the Planning Commission purview. Mr. Bellas would like council to consider reorganizing zoning and planning to include code enforcement.

Old Business: President Ruks met with VFD to discuss future needs. The department would like to purchase a new ladder truck estimated at a cost of 1.5 million. Engine 322 would become rescue truck. The department would like to sell Rescue 338, Argo & trailer with a total estimated value of \$159,000. The department would like to purchase a pick-up with a utility bed, a slide in skid unit, an enclosed trailer, and a Kubota side by side with tracks at a total estimated cost of \$145,000. Solicitor and finance director agreed that items would need to be declared surplus and anything over \$1,000 would need to be auctioned off on a site such as govdeals.com. This are exclusions when selling to another public entity. The VFD would like to remove office and relocated dept office to allow room for pickup & trailer. Dept is to provide value of current Ladder 331. Eventually, dept would like to replace engine 332.

President Ruks suggested Mr. Cottrell and Mr. Denihan meet with Solicitor Newcomb to discuss new contract and to make recommendations to council.
